Now that this year's tournament programme is nearly complete, planning for the next playing season needs to get underway. The WCA Executive Committee has concerns about the low level of support for our regional tournaments in the past year and would like responses to the following questions:

- 1. In what ways could you better promote your tournaments to encourage participation from players both within your Club and from other Clubs?
- 2. Do we need a means to communicate and celebrate the success of our tournament placegetters to perhaps motivate others to seek similar glory? What's needed?
- 3. Does your Club identify players with potential and provide encouragement by way of coaching and recommendation for tournament participation? If not, why not?
- 4. Does our tournament programme (content and scheduling) meet the needs of our players? If it doesn't, how should it be changed?
- 5. Should some tournaments be discontinued? Do all tournaments need to be on a weekend?
- 6. Should we introduce an Advantage GC tournament?
- 7. Do you have any suggestions regarding the Wednesday Team Levels Interclub (we will review the combined handicap for next season)?
- 8. Are you happy with the current tournament allocations? If not, what changes would you suggest?
- 9. Do you provide rules sessions (essential for all players) and encourage the seeking of qualification as referees in both AC and GC? If not, why not?
- 10. Do you think that some of these questions could be better addressed via a planning meeting of Club representatives during April?

Hopefully I have covered most things that needed a mention in this newsletter. However, I am sure Denise and John will keep AC and GC members informed/reminded of AC/GC events as required.

Let's also hope the weather continues to be kind to us for the remainder of the season. Note that PCC will be closed for play this winter season and we will be invited to play at the Waikanae CC. Due to the reciprocal agreement entered into with the Waikanae CC last year our members will not need to pay a per day playing fee to play at the Waikanae Club for the coming winter season.
